- 1 Auction Lot Numbers: Will be allocated by the Auctioneers - see declaration I and J.
- 2 Official Ear Tag: This must be the complete number.
- 3 Breed: Initials etc. are acceptable (eg. CH - Charolais, F - Friesian, Lim - Limousin etc.)
- 4 Initial: will do, S- Steer, H - Heifer, C - Cow, B - Bull.
- 5 Date of Birth: ie. 01 01 99
- 6 Farm Assurance. If you sell cattle as Farm Assurance registered they must have been on a Farm Assurance Holding for 90 days.
This can mean that they have been on your holding for 50 days and another holding for 40 days, however you must know the previous holdings Farm Assurance number. Please enter 'Y' if you are Farm Assurance registered and animal has been on a Farm Assurance holding for 90 days or 'N' if you are not Farm Assurance registered or the animal has not been on a Farm Assurance registered holding for 90 days.
